CSFA's will be required to earn 38 CE credits, in which 8 of those credits must be advanced credits. Advanced credits are defined as "CE sessions conducted by physicians at AST/ASA-approved conferences and workshops, AST state assembly meetings, employer in-services, grand rounds, physician professional meetings and by manufacturers intended for physicians."
